2. In the reference 2nd cited, the University has granted the Provisional Affiliation order to College of Pharmacy, Sri Ramakrishna Institute of Paramedical Sciences, 395, Sarojini Naidu Road, Coimbatore, for conducting the **M.Pharm.** Degree Course in following branches:

In the reference 3rd cited, the University has granted the Provisional Affiliation order to College of Pharmacy, Sri Ramakrishna Institute of Paramedical Sciences, 395, Sarojini Naidu Road, Coimbatore, for conducting the **Pharm.D degree course** with an annual intake of 30 seats **and Pharm.D (Post Baccalaureate)** degree course with an annual intake of 10 seats from the Academic Year 2008-2009.

4. In the references 4th cited, the University has granted the Continuance of Provisional Affiliation for conducting B.Pharm., M.Pharm., Pharm.D & Pharm.D(PB) Courses for the Academic Year 2023-2024 to the said institution.

5. In the reference 5th cited, the Pharmacy Council of India, New Delhi (PCI) has granted approval for the year 2024-2025 to the said institution for conducting B.Pharm., M.Pharm., Pharm.D & Pharm.D(PB) Courses.

6. An Inspection Commission was appointed on 11.07.2024 to verify the infrastructural and other facilities available at College of Pharmacy, Sri Ramakrishna Institute of Paramedical Sciences, 395, Sarojini Naidu Road, Coimbatore for the academic year 2023-2024.

7. Consequently, the requisite inspection was conducted on 22.07.2024 to verify the infrastructural, teaching and other facilities available at the said institution. On scrutiny of the inspection report, no specific adverse remarks or objection was found.


9. The seats available in B.Pharm./M.Pharm./Pharm.D/Pharm.D(PB) courses shall be filled as per the orders in force. The Management shall follow a transparent and reasonable method of admission for the management quota as per orders in force.

10. The admission procedure of the Government as per the scheme of admission enunciated by the Supreme Court of India should be followed.

11. The admission procedure as laid down in the G.O. of Health and Family Welfare Department, Chennai should be followed strictly. Any admission made over and above will not be permissible on any account.

12. The approval from relevant Council should be produced every year to consider further Continuance of Provisional Affiliation.

13. Any other condition which the University considers necessary to impose from time to time should be followed strictly.
